DELEGATE ASSEMBLY MEETING WAS HELD LAST EVENING: There were 18 representatives in attendance. We were able to safely social distance. Minutes of the meeting will be sent out in the next few days. Most of the districts that reported out are working with a hybrid model of instruction with a remote only component for a smaller percentage of the students. Those few that are still fully remote have a phase in plan to move to a hybrid model at the right time at some point in the future. Elizabeth Koch from Tonawanda CSD summed it up best "Kids in our district cheered as their bus pulled into the school parking lot to let them off for school. Everyone is happy to be back".

WRITING YOUR LEGISLATORS: Last week I encouraged Board Members to write their legislators regarding the release of Federal Funds to help mitigate losses. One of the board members wrote to her Federal Legislators this past week. She contacted me on Tuesday morning to let me know that she had sent an email to her elected officials and requested a response back from them. Please keep in mind that the emails do not need to be lengthy. They need to be direct and also provide details specific to your district. Elected officials frown on FORM LETTERS. I share her message that she sent to her elected officials below (with her permission). I did take the liberty to remove any information related to the specific district: Please watch for any advocacy alerts from ECASB.

As you know Governor Cuomo is threatening to cut all school funding by 20% if he does not receive Federal Funding. He also took \$500,000 out of our current funding as a Pandemic Adjustment and assured us we would get that back. We all know NYS has been in a deficit and on a spending spree. 1. Do you think NYS will get Federal Funding to help with Education and 2. How do we make sure it goes to the schools and he does not keep it? Please advise what School Boards can be doing to advocate for this funding? and anything else you feel we can do to help. Thank you I am on the XYZ Central School Board and would appreciate your response. Thank you.
